More than 450 people from over 85 churches throughout Victoria and Tasmania gathered at Berwick Church of Christ for the summit with the theme "Future Now". Inspirational presentations were given by CCVT Executive Officer Dr Rob Nyhuis, Dave Ferguson – Lead Pastor of Community Christian Church (USA) & CEO of the church planting movement Exponential and Professor Dr. Ruth Powell – Director NCLS Research.

CCFS Chair, David Warren outlined the financial performance of CCFS during the financial year, provided an update on the proposed merger with Baptist Financial Services (BFS) and introduced the BFS Chair Ross Langford (both pictured).
